#### Maritime Area Consent (MAC)

This form should be completed when applying for a MAC in accordance with section 75 or section 76 of the MAP Act 2021.

Section 79 states that a person may make an application in the specified form, accompanied by the specified fee, to MARA for the grant of a MAC for the occupation of the part of the maritime area the subject of the application for the purposes of the undertaking of the proposed maritime usage the subject of the application.

A person who is a body corporate may not make a MAC application unless it is:

- (a) a company,
- (b) an EEA company within the meaning of Part 21 of the Companies Act 2014.
- (c) a public body, or
- (d) engaged principally in non-commercial activities or works.

For the avoidance of doubt and notwithstanding any other enactment. MARA is not required to carry out, for the purposes of determining a MAC application:

- (a) a screening for appropriate assessment or appropriate assessment
- a screening for environmental impact assessment or environmental impact assessment.

- 1. The nature, scope and duration of the occupation of the maritime area concerned for the purposes of the proposedmaritime usage.
- Whether the proposed maritime usage is in the public interest.

- 4. Guidelines issued under *section* 7 which are relevant to the proposed maritime usage.

- 6. Whether the applicant is tax compliant, both at the time the application is made and at the time that the MAC application concerned is determined by MARA.
- 7. In the case of any maritime usage relating to offshore renewable energy (within the meaning of section 100), the consistency of the MAC application concerned with the development plans of the transmission system operator (within the meaning of <u>section 100</u>).

- The extent and nature of the preparatory work already undertaken by the applicant towards ensuring the efficacious undertaking of the proposed maritime usage the subject of the MAC application concerned should the applicant be granted a MAC in respect of such usage.

#### **Description of the proposed Maritime Usage:**

LCC wishes to carry out 40 linear meters of coastal protection works in order to protect a property (Eircode A91 XP62) on the shoreline at Drummullagh, Co. Louth, which lies just north of Omeath Village. Based on the High Water Mark at this location, there will be a requirement to be on the seaward side of the HWM over a short distance (approx. 40-45m) in order to allow for construction vehicles carry out the proposed works. A small portion of the permanent works (approx. 19sq.m) is proposed to be on the seaward side of the HWM. A summary of the proposed works is as follows:

- Site set up (fencing off works area etc)
- Excavate trench (40m long x 1m wide x 0.6m deep) for concrete footing,
- Pour concrete footing,
- Excavate trench (40m long x approx. 1.5m long x 1.0m deep) for rock armour,
- Install geotextile layer(s),
- Install rock armour.
- Backfill voids within rock armour with excavated material.
