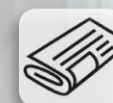

General Description of the Schemes

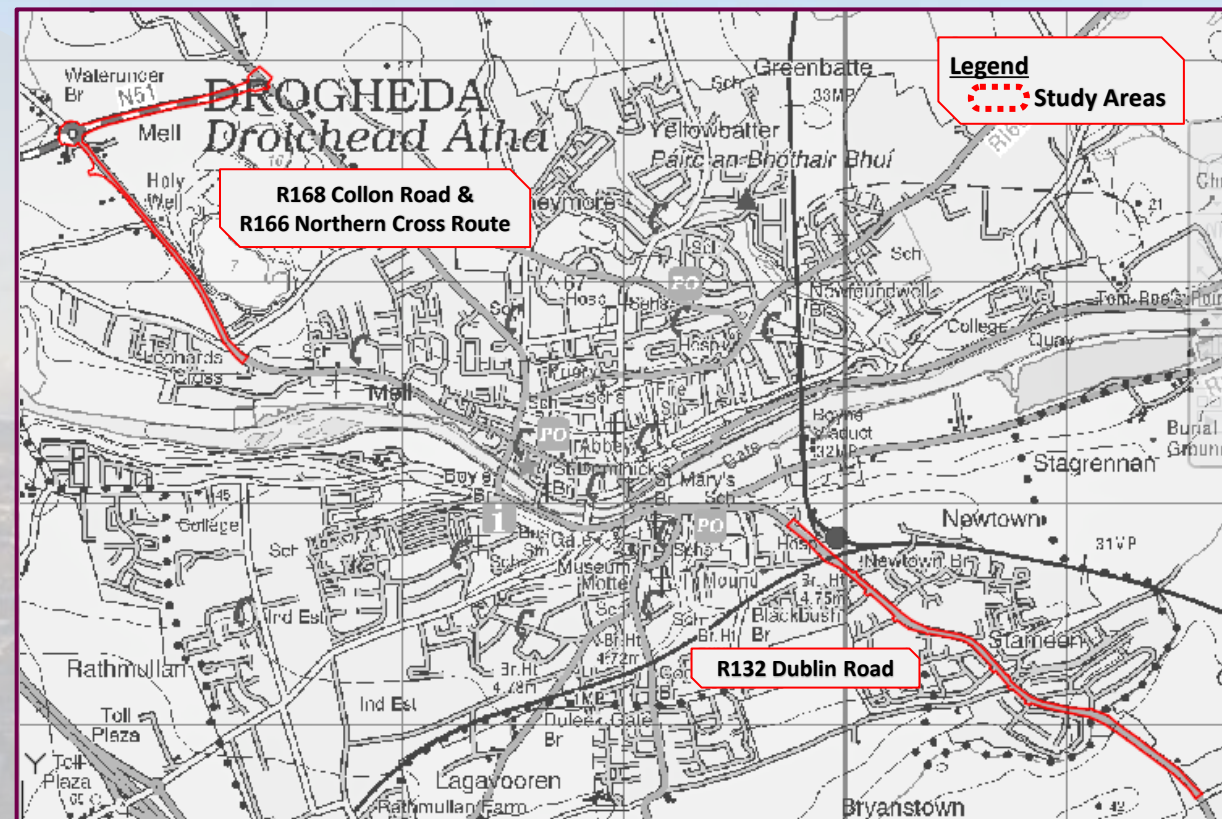


Figure 1- Study Area Map

The proposed Drogheda Active Travel schemes will involve the provision of active travel infrastructure across Drogheda town, including the introduction of cycle facilities and improvement to existing pedestrian facilities along the routes identified in **Figure 1**.

The improved streets will facilitate and encourage more sustainable modes of transport in Drogheda and provide safer routes for all road users. The schemes are also aimed to enhance smarter travel opportunities for both local communities and visitors and provide a better connectivity to local schools, healthcare facilities and sports/leisure centres in the area.

This phase 3 consultation covers the following two schemes:

❖ Scheme 1:

R168 Collon Road & R166 Northern Cross Route: This scheme will involve the provision and improvement of cycle facilities and footpaths along R168 Collon Road and R166 Northern Cross Route from Cement Road Junction to Rosehall Roundabout, where the scheme ties into R132 North Road Active Travel Scheme.

❖ Scheme 2:

R132 Dublin Road: This scheme will involve provision and improvement of cycle facilities and footpaths along the R132 Dublin Road from Drogheda MacBride Train Station to Southgate Shopping Centre. This scheme crosses between both Louth and Meath jurisdictions.

Needs for the Schemes

The key objectives of the schemes are to provide:

- ✓ Consistent, continuous, and safe facilities for all road users, to encourage active travel and more sustainable trips in Drogheda
- ✓ Together with other public transport improvement schemes (i.e. Dart+), to encourage modal shift for commuters and to improve quality of life
- ✓ Provide better connectivity and safer accesses to local schools, healthcare facilities and sports/leisure centres, among others
- ✓ To encourage outdoor activities by providing high quality walking and cycling routes for local communities and visitors
- ✓ To enhance opportunities for local business by increasing the footfall and accessibility to local retail units

What's Happening Now?

Louth County Council have commissioned their engineering design consultants, RPS, to progress the scheme development. The project team has developed an emerging preferred option for the typical road cross section and facilities for each scheme.
